The entry-level Master of Science degree in Occupational Therapy is designed to prepare graduates to assume key roles in practice, research, education or administration. Occupational therapists' responsibilities in these roles are to assure high-quality services for client groups and to advance the practice of occupational therapy.

NOTE: Applicants for the entry-level master's degree in Occupational Therapy follow procedures for submitting their application materials through the Occupational Therapy Centralized Admission Service (OTCAS). ALL applicants for the master's degree program in Occupational Therapy must complete the Graduate application and supplemental forms. ## Program Accreditation

Towson University's entry-level master's degree program is accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association located at 7501 Wisconsin Avenue, Suite 510E, Bethesda, MD 20814. ACOTE's telephone number is (301) 652-6611.

Graduates of the program will be eligible to sit for the national certification examination for the occupational therapist, administered by the National Board for Certification of Occupational Therapy (NBCOT). After successful completion of this examination, the individual will be an occupational therapist, registered (OTR). In addition, most states require licensure to practice; however, licenses are usually based on the results of the NBCOT certification examination. (Persons convicted of felonies may be unable to sit for the Certification Examination and should inquire in advance of program entry regarding eligibility.)

## Requirements

### Admission Requirements

Application deadlines and a full listing of materials required for admission can be found on the website.

### Prerequisites for Admission

Complete 8 prerequisite courses prior to entering the Professional M.S. Program. **Five of the eight prerequisites must be completed at**

**the time of application.** One must be in Anatomy and Physiology I or Anatomy and Physiology II. Any outstanding prerequisites must be completed with qualifying grades prior to beginning the program. **GRADE ALTERNATIVES:** Certain CLEP and/or AP scores may be used for non-science prerequisites, and medical terminology may be satisfied by a certificate course offered by an accredited college or university; visit the Admission Requirements & Deadlines page for specific details. Please contact us if your undergraduate degree was earned 10 or more years ago and you are concerned about your last-60-credit GPA.

- The following prerequisite courses must be completed with a "B-" or better:
  - a. Introduction to Sociology or Introduction to Anthropology
  - b. Abnormal Psychology
  - c. Basic Statistics
  - d. Human Anatomy and Physiology I with an **in-person lab**, taken within the last five years
  - e. Human Anatomy and Physiology II with an **in-person lab**, taken within the last five years
  - f. Human Growth and Development (must cover development across the entire lifespan)
  - g. Medical Terminology
  - h. Foundation in Mechanics (must include an in-person lab and include study of Newton's Laws of Motion). Often satisfied by physics or kinesiology course work.

## Degree Requirements

The professional Master of Science Degree in Occupational Therapy is 28 months completed over 2.5 years and consists of 71 units of graduate course work, which includes a graduate research project. All students complete two 12-week, 480-hour, full-time Level II Fieldwork experiences: one in physical disabilities and one in psycho-social practice (either may be with a children and youth focus), where they apply theoretical knowledge and demonstrate entry-level competence for a licensed occupational therapist. Level II Fieldwork is a full-time commitment often requiring additional time for preparation on the evenings and weekends. Students are advised that employment during this time should be limited to 10 hours per week. While local sites (within 90 miles of the university) are available, students may be assigned out of the local area or out of the state for one or both of the fieldwork experiences. All Level II Fieldwork must be completed within 24 months of completion of academic course preparation.

All students must complete the Occupational Therapy Knowledge Exam (OTKE) as a degree requirement, and the registration fee is covered by the department.

Completion of an online exit survey is required for graduation clearance in addition to successful completion of all other program requirements.

NOTE: Students have the option of earning a graduate certificate in Autism Studies or in Family-Professional Collaboration. Students who elect to earn a certificate may be required to extend the length of the master's degree program in order to complete the entire certificate program.

#### Annual Health, Insurance and CPR Requirements

All students in entry-level clinical OT programs must submit and maintain the health documentation as detailed in the Department of Occupational Therapy and Occupational Science Policy for Health, Insurance, and CPR Requirements to maintain good standing in the program and be eligible for fieldwork. Students who do not remain compliant with the requirements as outlined in the full policy will fall out of good standing in the program and may be prohibited from enrolling in course work and participating in fieldwork placements. The full policy is provided upon admission to an entry-level clinical OT program and available by request.

#### Abbreviated Departmental Health-related Documentation Policy

- Secure and maintain an account in Exxat education management platform (instructions provided upon admission).

- Annual PPD, Tspot, or Quantiferon Gold Blood Test required for duration of program.
- Adult Tetanus, Diphtheria, and Pertussis (Tdap) vaccination must remain current for duration of program.
- Positive Measles, Mumps, Rubella (MMR) Titer.
- Positive Varicella Titer.
- Positive Hepatitis B Titer OR Hepatitis B Declination Waiver.
- A Physical Examination (may be requested annually).
- Annual Seasonal Influenza Vaccine for duration of program.
- Current American Heart Association CPR Certification for Healthcare Providers for duration of program (Instructor-Led and Blended courses accepted; fully online courses are not permitted).
- Proof of Health Insurance Coverage for duration of program.
- Covid-19 Vaccination, including any subsequent boosters - *not required by program, but mandatory for most fieldwork sites, so vaccination is strongly encouraged.*
- Criminal Background Check(s) and/or Drug Test(s) as required for fieldwork.
